Achievements



- Now 34 member organisations as members, and still growing
- Extending partnerships, working with EFNA, WSO, ESO and EPF
- 3rd year of retaining a lobbying company in Brussels, Weber Shandwick
- Launched the Stroke Support Organisations Faculty tool (SSOFT)
- Secured funding for regional conferences, and other projects
- Worked in partnership with ESO on Stroke Action Plan for Europe. This was published in full in October 2018. We published the lay version and working on translations. We had major policy push in EU in March securing the support of the EU Presidency
- Achieved major breakthrough possibilities with EU on stroke
- Industry Partners meeting continues to develop next meeting July 10th in London





- A time of change as SAFE continues to grow membership, with limited resources
- A time of change with Board leaders moving to retirement, need new leaders
- A time of opportunity, policy breakthroughs and potential new projects on the horizon. Do we have the capacity and capability to seize the opportunities?
- A time of opportunity with diplomacy required to manage partners and members, for growing more projects. We need more engagement with them.
- A time of external challenges, with regard to others trying to take on our intellectual capital, trade marks, and subject areas.
- No funds available for Stroke Survivor Wants and Needs Survey
- It is a time of review, we have more demands with regard to our purpose and how we pursue it. We have future strategy and sustainability challenges


Finances, an ongoing struggle



- 2019 has continued to be a struggle as far as finances are concerned, with some sponsors having to cut back on funding
- We have outgoings we have to meet every month, salaries, hosting costs for websites, phone bills etc.
- Outgoings increasing
- Need more from membership fees
- Have to generate cash from activities, but how?
- Have built up some savings but these are rapidly being eroded

Strategy Review



- Board met in February
- Need to look at the situation because of the opportunities, challenges and cash flow situation
- Things have to be done in short term and some longer term issues
- Came up with specific issues and considered solutions

Conference/meeting funding



- At the moment we have not received full funding for the 2019 Working Conference and General Assembly in Porto in November. We need to cut the budget by approx. €40,000
- We therefore have two options currently available to us:
 - 1. Reduce the number of delegates funded to attend by SAFE from two to one from each organisation
 - 2, No longer have two SAFE conference dinners (with delegates providing for themselves in the evening instead) and cutting other costs such as gifts to delegates
- SAFE's preferred option is No. 2, but we would like the views of this conference on this.

Constitution Review to meet modern rules



- SAFE's Constitution has remained almost the same since being founded in 2004.
- We are currently in discussion with pro bono lawyers in Brussels to review the Constitution to ensure that it meets fully with up-to-date rules and regulations regarding NGO's registered in Belgium.
- SAFE's aim is to form a small committee to review the Constitution, and maybe change to having a Constitution and By-Laws. The Committee will work with the lawyers during 2019 and 2020 to produce recommendations to put to the General Assembly in 2020.
- We will be asking all members to review the Constitution for any suggestions/comments they may have.

President Elect Constitution Amendment



- Jon Barrick will retire as SAFE President at the GA in 2020, having served two terms on the SAFE board.
- To ensure the smooth transition to the next SAFE Presidency, the board would like to propose that a new position of President Elect be added to the current board structure.
- We would ask for proposals for this post at the GA in November this year, so that the President Elect could work alongside Jon for one year.
- We also need candidates for the board to step forward. All expenses are generally covered, in return for your voluntary work and expertise



- Need to consider new ways of holding conference that are financially viable
- At the moment we are dependent on sponsorship
- Need to be more self-financing to avoid uncertainty
- Life after stroke section in Action Plan does not have a conference for discussion of topics
- Can we fill this gap in the conference market. We would want to add delegates fees and exhibitors income to our revenue.
- Would start small in November 2020, General Assembly would be included in programme
- Would need a scientific committee to seek out speakers and help with marketing
- Chair of Life After Stroke domain group in the Stroke Action Plan is set to discuss this with us
- Could continue to sponsor at least one delegate from member organisations to attend if we receive sponsorship

Life After Stroke Forum topics

 - Stroke self-management
 - Therapy from a patient perspective
 - The economics of stroke
 - Stroke and social care and support
 - Peer support and stroke
 - Enabling equipment for stroke survivors
 - IT and software
 - Smart housing and the amelioration of stroke
 - Education, Information and Training content and issues around stroke knowledge and awareness
 - Robotics and stroke
 - Workforce licensing and stroke
 - Secondary prevention and the stroke survivor and their families
 - Wants and needs from a patient perspective after stroke
 - Stroke and mental health
 - Relationship issues after stroke
 - Multiple morbidity after stroke.

Proposals for action



Martin Seychell and Rokas Navickas proposed leveraging existing platforms facilitated by the EU - namely the CHRODIS + Joint Action, the Steering Group on Health Promotion, Disease Prevention and Management of NCD, and the Health Policy Platform - for future action on stroke.

Martin Seychell offered to facilitate discussions on the Stroke Action Plan for Europe within the Steering Group on Health Promotion, Disease Prevention and Management of NCDs, as well as to assist Member States in identifying priority actions, transferring best practices and assessing areas where the EU can add value through existing EU platforms.

Rokas Navickas proposed collaboration between SAFE, ESO and the CHRODIS + Joint Action, including the preparation of a potential future project on stroke. The Joint Action could contribute by helping identify stroke best practices currently implemented across Europe and supporting the development and implementation of a strategy for the transfer of those to different countries. Martin Seychell also invited patient groups and medical societies to join the Health Policy Platform, to interact with other key policy stakeholders, help raise the profile of stroke at EU level and drive community consensus on stroke specific policy issues.

Further options for future work were raised by Mikel Irujo Amezaga, namely a European Committee of the Regions own-initiative report, which he offered to support with, or an EP resolution. If issued, these could be leveraged by local patient groups and medical societies when engaging with national policy-makers to call for the implementation of the Stroke Action Plan for Europe's recommendations.

Next Steps:



• As a follow-up to the meeting, SAFE & ESO propose a number of policy actions that different EU policy-makers could take to assist EU Member States in decreasing the burden of stroke. SAFE and ESO call on:




How did we do in Social Media?

The performance of the digital strategy rolled-out for the event 'Joining forces to prevent and control non-communicable diseases: The role of policy in tackling stroke'



Goals & Objectives of the Digital Strategy



Executive summary



What has been done?

In Feb - March a Digital Strategy was rolled out at several levels, with these two as main pillars for the social media campaign:

- ✓ **SAFE Website:** an event webpage was created and continuously updated until the day of the event.
- Social Media channels: a social media strategy was set and implemented on Facebook and Twitter for a period of 6 weeks (from 20 February to 29 March).

Strategy implementation: Key overall findings

| POLITICO | EU Media | Dods and Politico shared the event with their community, which led to 82 clicks overall. |

Key learnings



| | Registrations | The number of people registering to the event was higher than usual. Having a structured digital campaign contributed to generating more interest around the event. |

| Ð | Live streaming | Even if not hundreds of people have seen it, live streaming the event allowed people across Europe to follow it on the day but also to have access to the recordings later on. |
| | Website | Having a webpage dedicated to the event is a way of driving traffic to SAFE's website and having a place where all information will permanently live. |
| | Targeted emails | ✓ When it comes to driving stakeholders' interest to the event, targeted emails were the most successful stream of the strategy. This was the platform that by far generated the most number of clicks and that led to the highest number of registrations (measured through clicks) |
| f | Facebook & Twitter | Both Facebook and Twitter are good platforms for SAFE to roll-out a digital campaign and they should be complementary. While Facebook generated more engagements, Twitter led to more impressions and URL clicks. Next time we would recommend considering a more structured paid media campaign to ensure optimal results. |
| POLITICO | EU Media | Although it is great to share news through EU media we have verified that the inclusion in the PoliticoPro Events calendar and the Dods alert did not generate much interest (measured through number of clicks). As free tools, they should nevertheless continue being used. |

Website: key findings





From 1 February to 31 March:

- There were 677 distinct individuals visiting the event webpage at least once. 147 were repeated visits from those 677 individuals.
- On average, visitors spent around 21 minutes going through the webpage which is 60% more than the website average.
- ✓ 70.75% of people that checked the event webpage exited SAFE website through the same page.

The event page was the fourth and third most visited page of the website in February and March, respectively.

Social media: key findings



- When considering impressions and engagements:
 - Content posted on the day of the event was in general more successful than prior to the event.
 - Video posts were generally the most successful and photo posts were in general more effective than text posts.
 - **Users engaged more with Facebook than Twitter content**. Content posted on Facebook generated more engagements (1,384) than Twitter (1,078) even though the campaign comprised only 24 Facebook Posts vs. 58 Tweets.
 - Twitter originated 3,5 more impressions than Facebook: 65,079 v.s. 18,850
 - **Facebook and Twitter users have clicked over 500 times on URL links.** On Facebook top 3 most clicked links redirected people to the event webpage, live streaming and the registration form. On Twitter the 3 most clicked links referred users to the Burden of Stroke Report, the Stroke Action Plan and the event webpage.

The Burden of Stroke in Europe Report revealed shocking disparities between and within countries along the entire stroke care pathway, with post-stroke support being neglected by all countries.

Economic Impact of Stroke Report and World Stroke Day 2019



The Economic Impact of Stroke in Europe: now and in the future, with recommendations on how to affect a reduction in the cost burden by investment

Initial Project Objectives



- Work package 1: The first objective of this work is to provide an up-to date (for the year 2017) estimate of the economic costs of stroke for all 28 countries of the European Union, by including direct health and social care costs, informal care costs (i.e. the unpaid care provided by relatives and friends of people with stroke) and productivity losses.
- Work package 2: Based on our projections of the cost of stroke in Europe for the year 2017, we will develop projections of these stroke costs for the next 10 and 20 years, i.e. we will provide estimates of the cost of stroke for the 28 countries in the EU and for the EU as a whole for the years 2027 and 2037.
- Work package 3: Finally, in our last objective, we will assess how improvements in stroke care can cost-effectively improve stroke outcomes across Europe by investing in: pioneering new interventions such as thrombectomy; better rehabilitative care for stroke survivors; and better stroke prevention strategies such as primary prevention of stroke in patients with atrial fibrillation.

Progress Work Package 1



- Initially, the study on the economic costs of stroke was to focus only on the 28 Member States of the European Union. However, after discussion, it was agreed that the project would include a further 4 countries: Iceland, Israel, Norway and Switzerland.
- **Methodology summary:** In order to provide estimates of the total economic costs of stroke, a threestage process in necessary. Firstly, data inputs need to be sourced, extracted and formatted; secondly, countryspecific, analytic models need to be constructed based on data sourced as well as extrapolation where necessary; and thirdly estimation of the total costs and reporting of the findings will be undertaken. Total costs will be estimated using a top-down approach i.e. using national expenditure data for each country, and reported in Euros for each country and as a total.

Progress Work Package 2



- As part of work package 2, we plan to explore the potential predictors and reasons for variation in stroke-related health and social care costs. For this, we will undertake regression analyses using: national income, total population, population-based incidence estimates (i.e. numbers of people experiencing a stroke), population-based prevalence estimates (i.e. total number of stroke survivors), life expectancy, standardized CVD mortality rates, physician density, and hospital beds per 10,000 population as independent variables.
- We have now obtained all these estimates for all 32 countries under study. In particular, we have obtained age- and gender- stratified estimates of stroke incidence and prevalence from the 2016 Global Burden of Disease Project.

Progress Work Package 2 (cont)



- Using these regressions, we will be able to assess the association of each explanatory variable on health social care costs. For example, it will allow us to assess what the impact on the costs of stroke will be, both in the EU, and in each individual country, of an increase in stroke incidence or prevalence. This will help us assess what the likely health and social care costs of stroke will be in 2027 and 2037 (i.e. 10 and 20 years from now). We have now also obtained, for the 32 countries under study, the age- and gender-stratified population estimates.
- To these projected costs of health and social care costs we will add the projected costs of informal care and productivity losses due to mortality and inability to work due to illness. So that these cost projections can then be compared to current estimates of the burden of stroke, all future costs will be valued in 2017 prices.

Progress Work Package 3



- In this work package we will estimate how stroke outcomes can improve and how the economic burden of stroke currently, and in 2027 and 2037, might change through increased investments in stroke care and research. In particular we will assess the impact on population-wide costs and outcomes, of investing in a number of priority areas in stroke care, including:
 - 1. better stroke prevention strategies such as primary prevention of stroke in patients with atrial fibrillation (AF);
 - 2. pioneering new interventions such as thrombectomy; and
 - 3. better rehabilitative care for stroke survivors.
- Much of the work is to inform the Markov model required to assess the effect of these interventions on outcomes and costs.

Milestones



- Work package 1: We planned to have finalised all the work necessary for Work package 1 by 31 October 2018. We will be using the same methodology as used in previous costing exercises of stroke to evaluate the costs of informal care, so we do not envisage any problems in evaluating these costs. We envisage that obtaining unit costs for nursing/residential home care for the 32 countries under study will be the most time consuming exercise of the remaining work in work package 1.
- *Work package 2:* Given that when Work package 1 is finalised we will have all of the data required for work package 2, we envisaged the analyses required for this work package to be finished by early December 2018. We then envisaged the work to have been finalised by end of December 2018.



World Stroke Day 2019

From Prevention to Life After Stroke



This year's main theme for SAFE's campaigning work remains Life After Stroke, the issues around it and how stroke survivors and their families are coping with it. The campaign will cover this year's European Stroke Awareness Day in May and will culminate on October 29, for the World Stroke Day, when SAFE will present the Economic Burden of Stroke in Europe Report.

The World Stroke Organisation's campaign this year is dedicated to Prevention. More information and campaign resources on stroke prevention will be available on the WSO website over the summer period.

Challenges



- After SAFE President stepped down from the WSC Chairman position, WSO radically changed course of communication, switching topics from Life After Stroke to Prevention
- This means that the resources they would produce would be still available for free, but about prevention.
- SAFE is strategically set in the direction of continuing with the Life After Stroke topic, because of past investments and because it needs it for building up towards the 1st European Life After Stroke Forum in 2020

SAFE's official political statement and motto is that the whole stroke care pathway equally matters, broadening communication in this year to all three major sections of the stroke care pathway (prevention/ treatment/ after stroke) would mean losing focus.

Life After Stroke topic underused in 2019

- Life After Stroke is a "blue ocean" at the moment, the medical and industrial community are traditionally focused on treatment and, to a slightly smaller degree, to prevention.
- Life After Stroke topics are central to the work of SSO's.
- Our SSOs are either run by stroke survivors or by their carers- stroke is a trigger for organising scattered individual struggles into making an SSO and advocating for change

Upsetting numbers play in our favour: 34% increase in number of strokes until 2035- ageing Europe will face rising needs of those who will survive 1 Mio of strokes, a challenge no one is quite prepared for now.

Building awareness takes years to achieve, we have to be dedicated to it.

Implementation

Stroke survivors' needs in North Macedonia: Lack of multidisciplinary teams in after stroke care

As announced earlier, SAFE will open conversation with our member organisations' leaders, in the attempt of shedding light on life after stroke issues across Europe.

This week we are talking with Dr Maja Bozinovska Smiceska, President of Association for a fight against stroke "Stroke" in North Macedonia.

SAFE: What is one issue related to the life after stroke in your country that you think needs special attention?

MBS: Every stroke is different, and so is the recovery that follows. Patients suffer not just physical problems like weakness and impaired gait, but also difficulties with language, memory, cognition and emotional problems. Patients everyday life changes and become full of obstacles and frustration.

One aspect regarding rehabilitation in their recovery is intensive work with multidisciplinary team. So, the first problem in our country is deficiency of such team in most of our cities or inequality in specialized stroke

Stroke survivors' needs in Georgia: Swallowing problems after stroke not addressed properly lead to lung infection

There is no stroke rehabilitation center in Kutaisi, Georgia, and after their hospital treatment, patients are discharged to go home. Unfortunately, patients' carers do not have enough information on how to take care of them once when lived encers are back home. Due to swallowing problem, many of strokes survivors return to the hospital very soon after their discharge, this time not because of stroke, but because of aspiration pneumonia- a type of lung infection that is due to a relatively large amount of material from the stomach or mouth entering the lungs' says Tamar Janelidze, MD, neurologist. co-founder and board member of Georgian stroke support organization, Medical Foundation Mixumali.

SAFE: What is one issue related to the life after stroke in your country that you think needs special attention?

T]: In Georgia, there is an observed growth trend in cerebrovascular diseases. For last years, at the national health sector level special attention is paid to acute strokes. In general stroke is one of the main Stroke survivors' needs in Portugal: Rehabilitation must be possible and accessible to everyone



What is common in stroke and dementia?

SVD refers to cerebral small vessel disease. It affects small arteries and capillaries in the brain and accounts for most cases of haemorrhagic (bleeding) stroke, a quarter of ischaemic (blockage) strokes, and contributes to at least 40% of dementia cases.

There are currently no treatments for SVDs and they are only partially understood. This new project will look at the common factors in multiple SVDs and will try to develop new treatments for the particular diseases that lead to dementia and stroke.







- The realisation of this joint project began in May 2018 simultaneously in twelve European countries: Spain, Serbia, Poland, Czech Republic, Latvia, Croatia, Macedonia, Greece, Ukraine, Georgia, Hungary and Turkey.
- The texts were kindly provided by Stroke Association UK
- Angels Initiative: Overall winner of the EFPIA Health Collaboration Award for 2018
- The SAFE Angels project is already positively influencing communication between healthcare professionals and patients. The information-rich brochures enable patients to understand more about their condition and to be more actively involved in their treatment decisions, with the aim of improving outcomes.

Current update

- The new project proposal for 2019 is in the approval procedure by the sponsor, Angels Initiative (BI)
- In addition to 13 languages from 2018, in 2019 SAFE plans to include Slovakian, and Hebrew and Arabic for distribution in Israel and East Jerusalem
- It is planned to have 1.000 copies of brochures per language
- Brochures in Serbian, Macedonian, Croatian, Georgian and Ukrainian have already been revised according to the Stroke Association information standards; These brochures are currently being visualy updated and adapted to the new format.
- Other project languages are in process of revision of the last years' versions
- Slovakian translation is agreed and ready to start
